

4-H YOUTH LOAN APPLICATION

The purpose of the 4-H Youth loans is to provide support to members of the 4-H Program by loaning money for the purchase of marketable livestock – beef, swine, sheep, or other projects approved by the 4-H Organization.

PROGRAM CRITERIA

Fees:

- A non-refundable application fee is required with application submission. Cash or Cheque payable to Community Futures East Kootenay is accepted.
 - \$25.00 for Steer
 - \$10.00 for Swine/Sheep

Eligibility:

- Must be a member in good standing with a 4-H Club.

Funding:

- Maximum \$1500 for Beef, \$300 for Swine, \$200 for Sheep.
- Individuals may apply for more than one loan up to a maximum amount of \$2000.

Repayment & Interest Rate:

- No payments required and interest free until August 31, 2020.
- Beginning September 1, 2020, 5% blended monthly interest will be applied to the loan until it is repaid in full.

SECURITY TAKEN

- Promissory Note signed by applicant and Parent/Guardian.
- Community Futures East Kootenay to be listed as loss payable for Insurance.

LOAN PROCESS

1. Applicant and Parent/Guardian to complete application form.
2. Club Leader to confirm 4-H Project and sign application form.
3. An in person meeting is to be set up with Community Futures to submit application and present information.
4. Community Futures will review the application form and determine whether the loan is approved or declined.
5. If the loan is approved, a meeting will be arranged for the Applicant and Parent/Guardian to sign the paperwork. *NOTE: Two pieces of Identification for the Applicant and Photo ID for the Parent/Guardian will need to be provided.*
6. Once the livestock has been purchased, the Applicant must provide Community Futures with a copy of the original bill of sale, paid invoice or receipt.
7. After 4 months, the Applicant is to contact Community Futures for a follow-up visit and provide photos of their livestock.
